

Anglia Revenues Partnership update	The ARP website includes a page specially designed to answer any questions around <u>Housing Benefit, Council Tax, Local Council Tax Reduction and Business rates</u> during the COVID-19 outbreak.
	We continue to be able to assist customers needing to make a new claim for Housing Benefit or Local Council Tax Reduction over the phone. This will be facilitated via call-back. There is limited availability so if able to access other support to do this please utilise this in the first instance.
	We would like to make sure our phone lines are used to support our most vulnerable residents, please continue to use and promote our <u>online forms</u> wherever possible.
	Please keep in mind, with regard to Local Council Tax Reduction, if a customer is applying for Universal Credit, they can indicate they wish to apply for Local Council Tax as part of their Universal Credit information gather, this will prompt a notification to the Local Authority. All five Local Authorities of the ARP accept a notification from DWP, in this way, as a new application for Local Council Tax Reduction, so a separate new claim is not needed.
	We continue to try and access supporting evidence via methods available to us that will negate the need for a customer to provide all information, if not readily available. If the claimant is unable to provide evidence electronically, and there is outstanding information, we will base our calculation on the information that is available and supplied via their application. We will follow this up later at a more appropriate time.
	A quick reminder - If you are supporting customers to make a new claim, if possible please let them know that ticking the appropriate consent boxes on claim forms will allow us to gather information from 3 rd parties, this will assist us all by minimising the information we need to request from the customer.
	Temporary absence from home outside Great Britain
	We are aware that there are claimants who travelled outside Great Britain (GB), expecting to return within their allowable period of absence under the Housing Benefit regulations, but have been prevented from returning due to travel restrictions outside GB. Easements are now in place which allow people to remain entitled to HB where they have been temporarily prevented from returning to GB due to COVID-19 travel restrictions. The usual rules on not subletting and having an intention to return still continue to apply to any period of temporary absence.

Council Tax update	Please be aware that Council Tax reminders have been sent to customers, these have been adapted to encourage customers to contact ARP and include advice for those who are struggling to pay their Council Tax. Taking into account the availability of Exceptional Hardship payments, the LCTR Scheme and Council Tax Hardship fund, we would ask customers to contact ARP as we may be able to offer a 12 month rather than 10 month payment period and will discuss any other options available to them at the time. Other news	An update regarding the UC47 process for requesting direct payment of Universal Credit Housing Costs Element or rent arrears deductions.		
	There is a new online service for landlords to request direct payments of rent or rent arrears. It replaces the existing UC47 process.		
	The new <u>digital form</u> is known as 'Landlord application for direct rent and/or arrears payments'. This replaces the UC47 form titled 'Landlord request for a managed payment/rent arrears deduction'.		
	All private landlords and social landlords (with tenants who are not on the landlord portal) will now use this digital form to request:		
	 a Managed Payment to Landlord (MPTL) Alternative Payment Arrangements (APA) repayment of rent arrears from their Universal Credit (UC) tenant 		
	Whilst there is a new form and process, the criteria for accepting an APA request has not changed.		
	Landlords should use this service to request payment of rent directly from a tenant's UC entitlement, if a tenant is having difficulty paying their rent.		
	Guidance on when to request a MPTL and/or rent arrears deduction from a tenant's UC entitlement can be found in the <u>Universal Credit and rented housing: guide for landlords</u> .		
	Ban on evictions extended by 2 months to further protect renters.		
	The suspension of evictions from social or private rented accommodation in England and Wales has been extended by 2 months until 23 August.		
	New court rules will also ensure vulnerable renters will be protected when the suspension of evictions ends. <u>Find out more.</u>
